## Paussies Adoption Agreement

Paussies (Hereinafter called "Breeder") offers for adoption the below described Miniature Australian Shepherd, under the conditions of the following agreement.

1. Buyer agrees to take the proper safeguards for the care, safety and well-being of the dog sold herein, including but not limited to regular veterinary care, to include any and all inoculations recommended, deworming, a fenced yard or proper kennel, adequate shelter, feeding and exercise, socialization, and obedience training.
2. Canine Health Record & Immunization information regarding dog up for adoption:
  - a. 1st Vaccine given, 12/29/18 Canine Distemper-Adenovirus Type 2-Parainfluenza-Parvovirus Vaccine. Please contact your vet to schedule your puppies 2nd shot (11-12 wks) and 3rd shot (15-16 wks).
  - b. Wait at least 2 weeks after the final puppy shot before giving the 1 yr Rabies Vaccine. It is best to be given around 6 months of age.
  - c. Do not allow any vaccines to be given with any other vaccine. Allow at least two weeks between ANY vaccines administered.
3. The Breeder recommends a diet of high quality grain, corn, and soy free food. Buyer agrees not to feed generic brand food to the dog.
4. Buyer further agrees that if for any reason in the future you do not wish to or are unable to keep this dog, the Breeder is to be notified and dog may be returned at Buyer's expense. Buyer understands that the Breeder will not buy the dog back.
5. The Breeder is to be notified of Buyer's change of address and phone number for record keeping.
6. It is in the best interest of the puppy to alter them between 4 and 6 months of age, for health and behavior reasons. BUYER WILL SPAY OR NEUTER THE PUPPY BY 6 MONTHS OF AGE and will provide verification from the veterinarian to the Breeder via US mail, or electronically. If verification is not provided by 8 months of age, the buyer agrees to pay the Breeder **\$2,500** (Typically 2x cost of puppy), at that time, to complete a breeder dog purchase.
7. This Agreement may be executed in counterparts. Executing an agreement in counterparts shall mean the signature of two identical copies of the same agreement. Each identical copy of an agreement signed in counterparts is deemed to be an original, and all identical copies shall together constitute one and the same instrument.
8. Facsimile or electronic transmission of any signed original document, and retransmission of any signed facsimile or electronic transmission shall be the same as delivery of an original.
9. In the case that any one or more provisions contained in this Agreement, or any application thereof, shall be invalid, illegal or unenforceable in any respect, the validity, legality or enforceability of the remaining provisions shall not in any way be affected or impaired thereby.
